
# WP4 RISKSAFE Pilot Report 1st Phase

## 1. Introduction

RISKSAFE is an Erasmus+ project that aims to empower older adults to apply affordable age-friendly and eco-friendly solutions in their own living environments. Through this, RISKSAFE aims to raise awareness on, and promote risk assessment and risk management in the community (older people living in their homes.

The RISKSAFE platform with the training contents and learning material is one of the main products of the project; it contains information, case studies, and exercises devoted to informal caregivers and seniors, structured in 4 different Modules and Sessions.

Present Report contains all main findings, information about participants, suggestions and recommendations, and final conclusions coming from the 4 National Pilot of Report of Finland, Greece, Italy and Sweden of the RISKSAFE PILOT – PHASE 1 (May 2025).

The general objective of RISKSAFE PILOT – PHASE 1 moves towards the implementation and the final release of the Learning Materials and the RISKSAFE e-learning platform.

#### Specific objectives are:

- Validation of the accessibility of the training contents and their integration/applicability in the older adults' way of living and daily life
- Validation of the comprehensibility and impact of the RISKSAFE e-learning platform
- · Revision of possible inadequacies, mistakes, or areas needing improvement

All National Pilot Reports will be collected, analysed, and summarised in the present Pilot Report – Phase 1 as a basis for minor changes and adjustments of the RISKSAFE training course (learning material, contents, and technical parts).



## **Implementation**

Duration of PILOT1st PHASE: 03.05.2025 - 18.05.2025

Implementation of all national pilots: online



#### **Finland-Turku University of Applied Sciences:**

Recruitment: email, phone. Most of them already contacted for WP2 interviews.



#### **Greece - FRODIZO:**

Recruitment: face-to-face meeting



#### **Italy - COOSS:**

Recruitment: email, phone, face-to-face



#### Sweden - Cul, Lärandeförvaltningen, Hudiksvalls kommun:

Recruitment: small groups in person

In all countries, the recruitment for pilots took place in the first week of Pilot 1<sup>st</sup> Phase duration.

At this stage, all potential participants were informed, by email or telephone or in person, about RISKSAFE and pilot objectives and were provided with all links: RISKSASFE platform (website and training course) and direct link to the evaluation survey in their own national language.

All answers were gathered by COOSS and the related partner responsible.

By May 18th, each partner had delivered their National Pilot Report to the WP4 leader, COOSS, in order to collect, analyze, and summarize them in the present document.



# Information on test participants

33 participants coming from 5 different countries.

50% of respondents were seniors, 30% caregivers and 15% experts of the sectors (risk management, caregiving, training) and 5% other.

All caregivers were "informal" ones living with the seniors and, all of them, have 1-5 years of caregiving experience.

50% of respondents were seniors, 30% caregivers and 15% experts of the sectors (risk management, caregiving, training) and 5% other.

All caregivers were "informal" ones living with the seniors and, all of them, have 1-5 years of caregiving experience.

# What was discovered – main findings:

Overall, the RISKSAFE Platform received good feedback from quite all respondents.

The average of the evaluation of Finland, Greece, and Italy closed answer was between 4 and 5 on a maximum of 5.

Only in Sweden, the average was a little lower than in other countries, with rating landed on 2.95.

#### **General overview:**

- Content and learning material: higher evaluation; participants gave good comments and feedback about all modules
- Navigation, platform functions, and confidence with the structure: some people find the
  platform difficult to navigate and don't feel confident in using it (they felt unsure,
  especially the seniors).

They found some typos in different languages to be fixed with INTERMEDIAKT. A list will be provided directly to the technical partner for each country responsible.

## General conclusions, notes or additional comments

To summarize, most of the participants showed a big interest and evaluated positively the RISKASE platform.

In particular, the training content and learning material of the RISKSAFE training course were really appreciated by respondents: they were considered detailed, consistent, and effective (See Table: To be kept)

Some navigation and usability aspects may be adjusted in order to facilitate the user experience (see Table: To be improved)

Typos, issues with the frame of the screen, and translation checks will be fixed directly between the national responsible partner and INTERMEDIAKT, the technical partner.

The consortium will take into account suggestions contained in the table (See Table: to be added/removed) according to their experience, objective, and common agreement.

The final result will be tested again in RISKSAFE PILOT - 2<sup>nd</sup> PHASE.
